Approval for the Risk Management Programme (RMP) Template for Dairy Processors – Ice cream, Domestic Supply

1. Background

- 1. Despite the general requirement that a risk management programme (RMP) is tailored to the individual business concerned, section 12(3A) of the Animal Products Act 1999 (the Act) allows for a RMP for a particular business, or part of a business, to be based on a template, a model, or a code of practice, if in the view of the Director-General the template, model or code of practice is valid and appropriate for businesses of that kind.
- The NZFSA has published the Animal Products Act 1999 Approval of Templates,
 Models, Codes of Practice Statement of Policy to clarify the application of section 12(3A)
 of the Act and provide the procedural arrangements for assessing and approving a
 template, model or code of practice.
- The NZFSA has developed an RMP template for dairy processors manufacturing ice cream for New Zealand and Australia only, referred to as the 'Risk Management Programme (RMP) Template for Dairy Processors – Ice cream, Domestic Supply'. The version approved is dated December 2008.

2. Justification

- 1. In making this approval the following have been considered:-
- a. The Risk Management Programme (RMP) Template for Dairy Processors Ice cream,
 Domestic Supply incorporation of regulatory requirements that are applicable for the kind of business concerned;
- b. The Risk Management Programme (RMP) Template for Dairy Processors Ice cream, Domestic Supply incorporation of Good Operating Practice, the application of HACCP principles, other RMP components, and requirements of DPC3 Manufacturing of Dairy Material and Products, Animal Products (Dairy) approved criteria that are appropriate for the kind of business concerned;
- c. Whether the Risk Management Programme (RMP) Template for Dairy Processors Ice cream, Domestic Supply has appropriate identification of regulatory requirements distinct from strongly recommended practice distinct from helpful information, and as relevant, an indication of what this distinction means in terms of application to a business; and
- d. Whether the Risk Management Programme (RMP) Template for Dairy Processors Ice cream, Domestic Supply is practical and achievable for the kind of businesses concerned.
- The Risk Management Programme (RMP) Template for Dairy Processors Ice cream,
 Domestic Supply meets criteria 2.1(a) (d). Feedback was received from

representatives of the New Zealand Ice Cream Manufacturers' Association and this was incorporated into the Risk Management Programme (RMP) Template for Dairy Processors – Ice cream, Domestic Supply.

3. In regard to the identification of regulatory requirements, recommended practice and guidance material, it is noted that the Risk Management Programme (RMP) Template for Dairy Processors – Ice cream, Domestic Supply has clearly identified the regulatory requirements in each section of attachment, however allowances for specific businesses to tailor relevant parts of the Risk Management Programme (RMP) Template for Dairy Processors – Ice cream, Domestic Supply to their particular operation are clearly identified and as such it is considered that the business application is clear.
