

# **Grazing Income Loss**

# Mycoplasma bovis Programme

### Can I claim compensation for my grazing income loss?

You may be eligible for payment of compensation if the Ministry for Primary Industries (MPI) has exercised powers under the Biosecurity Act 1993 (the Act) as part of the *Mycoplasma bovis (M. bovis)* Programme and these powers have caused you to incur a verifiable loss.

The exercise of powers is usually a Notice of Direction (NOD) or a Restricted Place Notice (RP). Here are some examples that may apply to your situation:

- My grazing land (farm) is under a Restricted Place Notice that has stopped other farmers from bringing stock on and off my property.
- I have lost a grazing agreement because stock cannot come onto or off my property.
- My grazing land (farm) was under a Notice of Direction that restricted another farmer's stock from moving off my property.
- My pastures were destroyed because the stock stayed on longer.
- I needed to repair the damage to my pastures and had to hire more staff and equipment than I normally would for that time of the season.
- I have lost a future grazing agreement because the pastures need to be rested and regrown.
- The stock grazing on my property have been directed to be culled.

## Who can claim and who is paid compensation?

To be a claimant you must be a person or business who is the legal owner of the property or goods that were destroyed or damaged, or goods that were affected by movement restrictions as a direct result of an exercise of powers authorised by MPI.

#### How do I claim compensation?

You'll need to complete and submit a Grazing Income Loss claim form. This claim form is available either from your Incident Control Point (ICP) manager, the MPI webpage or by contacting the Compensation Co-ordinator. We will be happy to email a copy to you.

Once you have completed the claim form, you can email a copy along with your supporting information or send it in via post/courier to MPI's compensation team.

You will find the list of relevant documentation needed to support your claim in Part 3 on the claim form.

#### When can I make a claim?

You can claim compensation from the date the loss was incurred, or within ONE YEAR from the date that verifies your loss. (MPI will only accept late claims in exceptional circumstances.)

#### Minimising my loss

In your claim form, give us details that demonstrate what reasonable steps you had considered or taken to minimise or avoid any ongoing loss.

Examples of possible alternatives include:

- Farmers who are fattening stock in preparation for culling.
- Other farmers under Notice of Direction who are looking for available pastures to graze their cows (where MPI provides permission to move the cattle).
- Farmers seeking to purchase your excess grass, hay or silage.


# How long will it take before I get paid?

MPI aims to process your claim and issue outcome letters (accept or decline) as quickly as possible once it has received your completed claim form and all supporting documentation. The average claim process is 20-25 working days. If all information is present and correct, then most claims can be assessed promptly.

#### Can I make more than one claim?

You'll need to make a separate claim for each of the different types of losses you have incurred. Doing this will allow MPI to assess each loss as they occur and make prompt payment. All claims should be submitted to MPI within ONE YEAR from the date of loss. If you incur further losses after being paid compensation, you may still make another claim.

#### **Process**



In some instances, MPI may need to contact you for further information either before an assessment can commence (the triage stage) or during the assessment process.
