OFFICIAL INFORMATION ACT REQUEST

I refer to your official information request of 23 June 2015 relating to swamp kauri export.

Following the release of my decision last week, the following information is released to you under the Official Information Act 1982:

- milling statement, intention to export form and inspection form for application AK706 (as per the first part of your request);
- milling statement, intention to export form and inspection form for application AK765 (as per the second part of your request);
- milling statement, intention to export form and inspection form for application AK657 (as per the third part of your request);
- tables detailing the export of swamp kauri since 2009 and milling statements issued for swamp kauri since 2004 (as per the fourth part of your request); and
- all correspondence between MPI officials and Oravida, NZ Forests Ltd and Kauriworld (as per the fifth part of your request).

Please note that in respect of the first part of your request, the initial intention to export application submitted in 2013 was withdrawn by the exporter. However, an export of nine swamp kauri stumps by the same exporter was approved in 2014, hence the release of information pertaining to that export (AK706).

Following clarification with you about the volume of documents the fourth part of your request would cover, it was agreed that the request would be restricted to provision of tables of summary information from which future OIA requests for further details can be made.

In respect of correspondence requested in the fifth part of your request, as agreed with you a table summarising correspondence between MPI and the noted companies is provided. Email correspondence in relation to Kauriworld has been included within the scope of your request as Kauriworld is a related company of NZ Forests Ltd.

The part of your request regarding all correspondence with AsureQuality (separate to any correspondence with the above parties) has been refused under section 18(f) of the OIA as the information requested cannot be made available without substantial collation or research. I suggest that you consider narrowing the scope of your request, based on the information supplied to you as part of this OIA response.

I have withheld some information in these documents pursuant to section 9(2)(a) of the Official Information Act, to protect the privacy of natural persons, and under 9(2)(b)(ii) where it is likely to unreasonably prejudice the commercial position of the subject of the information. I am satisfied that in the circumstances of this case, the withholding of this information is not outweighed by other considerations which render it desirable in the public interest to make the information available.

You may be interested to know the Ministry for Primary Industries (MPI) has proactively released a large amount of information on swamp kauri on the MPI website here: <http://mpi.govt.nz/exporting/forest-products/wood-and-wood-products/swamp-kauri>. This OIA release, with your contact details redacted, will also be published on the website.

You have the right under section 28(3) of the Official Information Act to seek an investigation and review by the Ombudsman of our decision to withhold information. A request must be made in writing to:

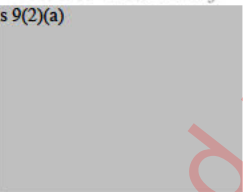
